The dog owner agrees that dog shall not leave kennel until all changes are paid by owner. The kennel shall have, and is hereby granted, a lien on the dog for all unpaid charges.

The dog shall be boarded or trained, or otherwise cared for by the kennel without liability on the kennel's part for loss or damage from disease, death, running away, theft, fire, injury to other persons, or property by the dog, or other unavoidable causes, reasonable care have been exercised. In no event shall the kennel be liable for any amount in excess of the charges to the dog owner hereunder.

If the dog becomes seriously ill, the dog owner shall be notified at once at the phone number listed above. If the dog owner cannot be reached within an appropriate period of time, if the dog owner does not inform the kennel immediately of the measures to be taken, or if the state of the dog's health demands quick action, the kennel shall have the right to call a veterinarian of the kennel's choice or take the dog to a veterinarian or to administer medicine or give other advisable attention, within the kennel's discretion and judgment. All costs and expenses incurred in connection therewith shall be paid immediately by the owner.

If any changes for boarding, training, medicine, veterinary services, or damages are not paid within ten days after they are due, or if the dog is not picked up within ten days after time for return of the dog, the dog may be sold by the kennel, publicly, privately, or otherwise for any and all unpaid charges. Notice of such intended sale shall be mailed by registered mail to the dog owner at the address on file, not less than ten days before the date of intended sale and no further notice shall be deemed necessary. The dog owner hereby waives all statutory or legal rights to the contrary. Any excess amount over the charges will be paid to the dog owner, and any deficiency immediately shall be paid to the kennel by the dog owner.

The dog owner represents that he is the legal owner of the dog, that the title to the dog is not mortgaged in any way, that the dog has not been exposed to distemper or rabies within the last thirty days, and that the required annual license has been obtained. Owner agrees to pay for all damages caused by the dogs, and agrees to the use of a citronella collar if dog barks excessively.
